New Exemption Policy Effective from June 2020 Exams

(1) Exemption in AMIETE can be granted to the students who have passed the corresponding subject while acquiring any Diploma or higher qualification provided the syllabus studied by the student matches at least 80 % with the IETE syllabus.

(2) Exemption in DIPIETE can be granted to the students who have passed the corresponding subject while acquiring 10+2 or higher qualification provided the syllabus studied by the student matches at least 80 % with the IETE syllabus.

(3) For DIPIETE students pursuing AMIETE, following is the list of subjects for which exemption can be granted:

(4) Student will have to submit copy of syllabus he has studied duly attested by the HoD/Principal of the college/institution, final certificate and mark sheet along with the application for exemption.

(5) IETE may get the syllabus and credentials verified from the College/University if required.

(6) Mapping of the syllabus will be done by the Academic or Sub-Academic Committee constituted by the Chairperson Acad committee.
